The rise and application of advanced information technologies means there is a great opportunity for knowledge building, community interaction, innovation, and collaboration


#### GDHP "Policy Environments Workstream" aims to integrate digital technologies into policy frameworks

#### Overarching areas of the Policy Checklist

- > Robust Technology
- > Human Factors
- Includes 24 policy areas as elements of digital health policy
- Provides an 'heatmap' of the policy coverage of GDHP countries – informing about countries gaps in digital health policy areas


# **User Guide 1: Policy Dashboard**

The Policy Dashboard contains the 'heatmap view' of the policy elements covered by a country or the entire GDHP country members

Toggle to view either:

- 1. Total count of policies in the database; or,
- 2. Whether or not there is a policy in that area

**Toggle** to select either an individual country or the total of all policies in the database, *All GDHP Countries* 



# Each country has their own sheet which can be used to both **input** and **view** their policy data. In the input section, there are a few areas of action.

- 1. Type: To select if the document included is a Policy, Strategy, Implementation Guide, or Case-Study / Solution
- 2. Document Title: The title of the document or policy. There are several 'themes' (e.g. Health Data Use and Exchange) under which different policies can be placed, however, these are non-consequential and more to aid the user
- 3. Document Link: Please include the direct link to the document or policy these will be used directly in the dashboard
- 4. Policy Checklist Mappings: Input areas for the most relevant policy elements. Write "X" under the qualifying policy elements. These are abbreviated titles. Full definitions of the policy areas can be found in the Policy Checklist Reference Document


